

MINOR WAIVER AND RELEASE FROM LIABILITY FOR Eastern Pro Rodeo Association

The application must be notarized if the applicant is less than 18 years of age & signed by parent or guardian.

I, _____, on behalf of (hereinafter referred to as "MINOR") HEREBY WAIVE AND RELEASE, indemnify, hold harmless, and forever discharge Eastern Pro Rodeo Association, and its agents, employees, officers, directors, affiliates, successors, and assigns, of and from any and all claims, demands, debts, contracts, expenses, causes of action, lawsuits, damage,s and liabilities, of every kind and nature, whether known or unknown, in law or equity, that I or MINOR ever had or may have, arising from or in any way related to MINOR'S participation in any of the events or activities conducted by, on the premises of, or for the benefit of, Eastern Pro Rodeo Association, provided that this waiver of liability does not apply to any acts of gross negligence, or intentional, willful or wanton misconduct.

I understand that the activities the MINOR will participate in are inherently dangerous and may result in serious injuries, including bodily harm, emotional distress, property damage, or even death. On behalf of myself, the MINOR, my heirs, assigns, and next of kin, I, and said MINOR, waive all claims for damages, injuries, or death that I or the MINOR may have against the aforementioned released party arising from such activities.

MINOR has the necessary and requisite skills to participate in all facets of, and activities of and requested of this facility, except as noted below.

The activities involved have been fully disclosed, and any related flyer, advertisement, or brochure is included as part of this WAIVER AND RELEASE. I agree that if at any time I believe conditions are unsafe, I will immediately exercise my parental or guardianship rights to stop the MINOR's participation.

By signing this Waiver, I, on behalf of the MINOR, assume all risks and waive claims for personal injury, death, or property damage associated with rodeo activities, including but not limited to bull riding, barrel racing, training, or using the facility and equipment. This includes participation in events such as bullfighting, judging, announcing, or other related activities both on and off the premises.

This WAIVER AND RELEASE represents the entire agreement between the parties, replacing any prior agreements. It can only be changed or amended in writing with the consent of all parties.

The terms of this WAIVER AND RELEASE remain effective even after the activities have ended, whether by agreement, law, or other means.

By signing, I confirm that I have read and fully understand this WAIVER AND RELEASE. I acknowledge that I am voluntarily waiving significant future legal rights on behalf of the MINOR. My signature reflects my full agreement with these terms.
